



# AGREEMENT BETWEEN DEFENCE SERVICES MEDICAL ACADEMY, MINISTRY OF DEFENCE, THE REPUBLIC OF THE UNION OF MYANMAR AND THE KURGAN STATE UNIVERSITY OF THE RUSSIAN FEDERATION ON SCIENTIFIC AND RESEARCH COOPERATION

The Federal State Budgetary Educational Institution of Higher Education 'Kurgan State University' on the one part, and Defence Services Medical Academy on the other part, hereinafter referred to as Parties, note the importance of cooperation development and friendly relations between scientific institutions. In light of this and in order to promote the development of fundamental and applied scientific research in the field of chemistry, biochemistry, non-ferrous metallurgy, traumatology, ceramic materials technology, mechanical engineering, as well as to promote scientific and technical progress, and, based on the interests of developing traditional friendly relations, the Parties agreed on the following.

## Clause 1

On the basis of the principle of mutually beneficial and equal rights, the Parties have agreed to open a mirror laboratory "Advanced Materials for industry and Biomedicine" (Defence Services Medical Research Centre, Nay Pyi Taw) for cooperation in the field of chemistry, biochemistry, non-ferrous metallurgy, traumatology, ceramic materials technology, mechanical engineering.

#### Clause 2

The Parties will cooperate in accordance with the current legislation of each country, and in accordance with the agreements and treaties concluded between the Russian Federation and the Republic of the Union of Myanmar.

#### Clause 3

The Parties shall apply the following forms of cooperation:

- (a) conducting joint research;
- (b) exchange among researchers;
- (c) exchange of main journals, articles and books published by both organizations, publication of articles from them in the universities' journals;
- (d) joint holding of scientific conferences, symposia and other scientific events;

- (e) cooperation in consulting activities;
- (f) training of young researchers;
- (g) other forms upon Agreement between the Parties.

#### Clause 4

Changes and amendments to this Agreement shall be made by mutual written consent of the Parties.

## Clause 5

This Agreement shall enter into force on the date of its signing and shall be valid for three (3) years. It will be automatically extended for the next three years if neither Party notifies the other Party in writing, at least six (6) months before the expiration of the relevant period of this Agreement, of its decision to terminate it.

# Clause 6

- The termination of this Agreement shall not inflict programs and activities of (a) cooperation started within the framework of this Agreement and unaccomplished at the moment of its termination unless otherwise agreed by the Parties.
- (b) Any disputable matters arising from implementation of this Agreement related to its interpretation and application shall be settled by the Parties through consultations and negotiations.
